CLAUSE 1 CO-OPERATION

CLAUSE 2 SCOPE OF THE MoU

CLAUSE 4 VALIDITY

- H) This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **IAPMO India Private Limited.**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **IAPMO India Private Limited, the Second Party** is promoted by **Dr. Nimish Shah**
- 4.1 the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.




