Extraction of Phytochemicals from Ocimum grandiflorum and its Uses as a Food Supplement

Abstract

A number of phenolic compounds with strong antioxidant and antimicrobial activities have been identified in plants, especially in those belonging to the Lamiaceae family. *Ocimum grandiflorum* one of the members of the Lamiaceae family has shown to possess important phytochemicals which can be used as antioxidants to work against free radicals in the human system. In this research paper the important secondary metabolites of *Ocimum grandiflorum* were extracted and quantified.

Free radicals are produced through the normal process of any metabolism. However, these days there are additional sources of free radicals in our environment. Indoor and outdoor air pollution, home cleaning products, personal care products and cigarette smoke are the common sources of these free radicals which cause premature ageing and various other diseases.

The leaves of *Ocimum grandiflorum* were extracted using methanol and alkaloids, tannins, saponins and total polyphenols were determined. The estimation of alkaloids, tannins, saponins and total polyphenols of the leaves gives a view of its medicinal properties. The quantitative analysis of phenolic constituents was determined by using high–performance liquid chromatography. The phenolic constituents were screened for antiradical activity.

Karnataka is one of the states of India most seriously affected by the HIV/AIDS epidemic and stands fifth on the number of reported AIDS cases in the country. The first case of AIDS was detected in the State in 1988. Of the 49 high prevalence HIV/AIDS districts in India, 10 are in Karnataka. Bijapur is one of the Districts in Karnataka where many people are infected with HIV/AIDS.
