## Studies on Enhancement in the Antimicrobial Properties of Two Vermicompost Treated Aromatic Medicinal Plants

#### Abstract

The term 'Medicinal Plant' encompasses varied plant genera used in herbalism which are considered as rich sources of ingredients that can be used in drug development and synthesis. These plants find applications in synergic medicine or as support to the official medicine or as potent preventive agents. Many of the pharmaceuticals currently available possess a long history of use as herbal remedies, including aspirin, quinine and opium. Some of these plants are endowed with aroma characteristics. These plants have been used for thousands of years for many different purposes ranging from medicinal to religious, from protecting against spirits to culinary delights. Cultivation of these aromatic medicinal plants provides scope for the improvement of quality of the drugs which are in growing demand. In the international market, the present export of herbal raw materials and medicines from India is about US dollar 100-114 million/year. The present paper aims at disclosing the enhancement of antibacterial properties of two vermicompost treated aromatic medicinal plants viz: i) *Pelargonium graveolens* (fam: Geraniaceae) and ii) *Origanum syriacum* (fam: Laminaceae) in contrast to the control samples.

#### Abstract

# **Evaluation of** *in vitro* **Cytotoxic Effects of** *Symplocos cochinchinensis* **against HeLa and MCF7 Cell Lines**

#### Abstract

The present study was performed to determine the cytotoxic effects of the ethanolic and ethyl acetate extracts of *Symplocos cochinchinensis* bark against HeLa and MCF7 cell lines. Five different concentrations (12.5, 25, 50, 100 and 200  $\mu$ g/ml) of each extract were assessed for its cytotoxic activity. The results revealed that 200 $\mu$ g/ml of both the extract have significant cell growth inhibition based on concentration dependent manner. Based on the IC<sub>50</sub> value, ethyl acetate extract showed higher *in vitro* growth inhibition and effective level of potency to reduce HeLa cell and MCF7 cell viability compared to ethanolic extract. Thus from the results it was suggested that the bark of *Symplocos cochinchinensis* possess cytotoxic properties and can be used as an anticancer agent.

### The Black and White of Racial Stereotypes: Kwame Kwei-Armah and Bruce Norris

#### Abstract

The paper attempts an examination of two plays, Clybourne Park by the white American writer Bruce Norris and and Beneatha's Place (a work in progress) by African-American writer Kwame Kwei-Armah, in relation to Lorraine Hansberry's 1959 play A Raisin in the Sun. Both plays claim and have a close link with Raisin, but in very different ways. Hansberry's work in 1959 came at a crucial time of African-American history, when the anger and angst of the Harlem Renaissance had paved the way for open struggles against racial segregation, socio-economic injustices, and the fight for civil rights and racial equality. Underpinning these issues is the notion of racial stereotypes, which, to a large extent, can be seen as one of the outcomes of racial prejudices. Hansberry's play addresses, in part, the issue of racial stereotypes in the specific context of an African-American lower middle class family's attempt at self-determination through the enactment of their socio-economic aspirations. Their struggle to break the class/race nexus posed by the so-called mainstream white society is set against the backdrop of their community's racial history in America. The complexities and divisive conflicts of African-American identity politics are sounded in Hansberry's play, but are more or less subsumed in the larger racial black vs. white narrative. The plays of Kwei-Armah and Norris take up specific aspects of racial stereotypes that are gestured towards in Hansberry's work, and develop these further along the lines of contemporary debates, but crucially, from distinct and separate race positions. Both plays take into account the intervening five decades of African and African-American racial history and their role in the evolving of racial identities. The paper attempts to identify and highlight the different ways in which the notion of racial stereotypes and its impact on identity is developed in both the plays.

Calcutta, which was the capital city of British Indian Empire, lost its position to Delhi in 1911. The Decision was announced in the Delhi Durbar 1911 together with the decision of revocation of Bengal partition. The two decisions were interconnected and kept amidst secrecy till the last moment. However the decision of transferring capital was indeed a major decision which had a strong background and a long-lasting effect as well. ## Forecasting Volatility of Gold Futures Prices: Evidence from Multi Commodity Exchange of India

#### Abstract

Gold futures as financial asset has occupied imperative position in terms of trading volume and turnover in the Multi Commodity Exchange of India. With increasing interest and attention towards Gold among the investors, the present paper attempts to forecast the volatility of Gold prices of Multi Commodity Exchange, using daily data covering a period from 2nd May 2005 to 31st July 2015. The forecasting models that are considered in this study range from the relative simple ARIMA (2,1,2) model to relatively complex GARCH models (including GARCH (1,1), Exponential GARCH (1,1) and Threshold GARCH (1,1) models). Based on sample forecasts and a majority of evaluation measures our result shows that EGARCH (1,1) model outperformed all the other models in forecasting volatility of Gold returns. This is followed by the GARCH(1,1) model and TGARCH (1,1) that performed better in forecasting the conditional volatility of the Gold returns. The study suggests that the EGARCH (1, 1) model performs better in forecasting conditional variance of the Gold returns rather than the symmetric and linear ARIMA model, confirming the presence of leverage effect.
